The Caribbean-Canada Emerging Leaders' Dialogue (CCELD) pairs leaders from different countries, across labour, business, government, NGO's and civil society for two weeks. The programme is built on the proven model of the Duke of Edinburgh's Commonwealth Study Conferences that brings together high calibre mid-career individuals, who this year focused on the theme Leading Through Innovation and Transformation.

This initiative is geared at providing participants with intensive learning and networking opportunities, and allows them to develop peer-to-peer critical leadership competencies, including abilities to collaborate, integrate and think critically. The Dialogue guarantees a profound personal experience, expanding the participant's knowledge of fundamental global and local issues, and gives insight into the thinking of top leaders. As part of the exercise, the participants break into small groups to meet with leaders in communities, workplaces and institutions to discuss challenges, systems and solutions.
